HOW TO ENTER

These rules govern the Neil Young (OS) online ticket giveaway ("Contest"), which is being conducted by KZNS ("Station"). The Contest begins on May 2, 2024 and ends on May 13, 2024 ("Contest Dates"). Entrants may enter via online entry only.

To enter the Contest, entrant may enter online at kslsports.com/contests on May 2, 2024 at 8 am MT and ending on May 13, 2024 at 12 am MT ("Entry Period") as follows:

Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.

Only one (1) entry per person is permitted. There will be up to a total of six winner(s) selected in the Contest each week.

All online entries must be received by the end of the Entry Period.

ELIGIBILITY RESTRICTIONS

The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older. Void where prohibited or restricted by law.

The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to **ENTERING THE CURRENT CONTEST** are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to **ENTERING THE CURRENT CONTEST** are not eligible to participate. These restrictions also apply to immediate household members of contest or prize winners.

This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

PRIZES

The Approximate Retail Value ("ARV") of the prize(s) is \$100. Transportation costs are **excluded** in the given price. The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). **Tickets** are valid only on the date(s) printed on the **tickets**, and they are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for cash or

credit at any time, nor will they be replaced if lost or stolen. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station or Contest Administrator or Sponsor, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Contest cannot be conducted and/or if a prize, either in whole or in part, cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism, or other factors beyond the Released Parties' control.

- f. Utah law governs the interpretation and construction of these Official Rules and all aspects related thereto.
