- a. These rules govern the Salt Lake Bees Online Ticket Giveaway Rules ("Contest"), which is being conducted by KZNS ("Station"). The Contest begins on April 18, 2024 and ends on August 19, 2024 ("Contest Dates"). Entrants may enter via online entry.
- b. To enter the Contest, entrant may enter online at kslsports.com beginning on April 18, 2024 at 2 pm MT and ending on August 19, 2024 at 12 am MT ("Entry Period") as follows:
- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Entrants provided opportunity may be with an opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.
- e. Only one (1) entry per person is permitted per entry period. There will be up to a total of twelve winner(s) selected in the Contest.
- f. All online entries must be received by the end of the Entry Period.

#### 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older. Void where prohibited or restricted by law.
- b. - c. Odds of winning depend upon the number of eligible calls received during the applicable Drawing Period.
- d. Entries are specific to each designated Drawing Period and will not be included in subsequent drawings.
